1. A separate entry form must be used for each entry. Additional forms may be photocopied.
2. Closing date for entries – **Friday, 15th January 2021**. Late entries (up to 22nd January) are subject to a £10 surcharge per entry.
3. Entries should be sent, together with the appropriate fee, to arrive on or before that date, to the Secretary, **Mrs M.E. Waterston, 35 Buchan Drive, PERTH, PH1 1NQ**, cheques being made payable to '**Perthshire Musical (Competition) Festival Association**'.
4. If confirmation of receipt of application is required, the section at the top right of the entry form **must** be filled out by the applicant and a stamped addressed envelope, marked '**Receipt**', enclosed. Failure to receive an expected response should be followed up by an email (perthcompfest@hotmail.com) or telephone call (07849 745000).
5. If a financial receipt is required, please enclose a further stamped addressed envelope.
6. Applicants will be sent a summary of all entries, after the initial closing date. Any errors not notified immediately to the festival will be carried forward to the programme. Forms must be completed in full by an adult and signed.
7. If Own Choice details are not known at the time of entry, the form will be accepted on the understanding that a replacement form, clearly marked '**Replacement Form**', is **completed in full** by 1st February at the latest.
8. All entrants are bound by the regulations in the current syllabus. Failure to submit copies of music as specified in the regulations may result in disqualification.
